## **2016 Day Shift – Significant Events**

### **Problem Oriented Policing:**

**POP PROJECT:** There were no POP Projects completed by Day Shift officers in 2016.

## **Special Assignments**

Several day shift personnel participated in combined traffic details with the Traffic Unit during the year in order to enforce traffic laws and provide a safe environment for the motoring public. These details included the following enforcement actions: distracted driving, speeding, school zones, DUI enforcement, improper lane usage, improper stopping on roadway, registration violations and overweight truck violations. New signs were erected in the Village parking lot for “No Parent Drop Off”. Several day shift officers assisted in educating the parents of the existence of the new signs and assisted the traffic officers with enforcement.

## **Status of Goals for 2016**

1. Assign shift officers to conduct at least six traffic details throughout the year. Details may include distracted driving, speeding violations, school zones, etc. *Status:* In April, officers assisted the Traffic Safety Unit with two overweight trucks and expired apportioned license registration details. In August, officers

assisted the Traffic Safety Unit with four Back to School details. In September, officers assisted the Traffic Safety Unit with one Back to School detail. This goal has been met.

2. Assign shift officers to conduct at least four warrant details throughout the year as manpower allows.

*Status:* In February, officers conducted two warrant details. In April, officers conducted one warrant detail. In September, officers conducted one warrant detail. This goal has been met.

3. Assign shift officers to conduct four parking violation details throughout the year as manpower allows.

*Status:* In February, officers conducted one parking enforcement detail. In November, officers conducted two parking enforcement details. In December, officers conducted two parking enforcement details. This goal has been met.

## **Goals for 2017**

1. Assign shift officers from both Team A and B to conduct at least four traffic details throughout the year. Details may include distracted driving, speeding violations, school zones, etc.
2. Assign shift officers of Team A and B to implement a P.O.P project during the year.
3. Assign shift officers from both Team A and B to conduct a minimum of six parking violation details throughout the year as manpower allows.
