## **Special Assignments**

Officers assisted Investigations with several search warrants.

Officers worked in plain clothes patrolling the high crime areas. Several arrests were made for drug possession, criminal trespass and outstanding warrants.

Officers participated in landlord/tenant meetings, College Apartments/Indian Trail Apartments management meetings, park meetings and Neighborhood Watch meetings throughout the year.

Officers participated in numerous traffic details during the year in order to enforce traffic laws and provide a safe environment for the motoring public.

Officers assisted with ATAC/Detectives on ATAC investigations or call-outs.

## **Goals from 2017:**

1. **Increase DUI arrests by 5% from 2016.**  
*The goal was for 91 DUI arrests. Officers made 62 DUI arrests in 2017. This goal was not accomplished.*
2. **Conduct three enforcement sweeps (Warrant Sweep, Parole Compliance, and Saturation Patrol).**  
*Officers from the Midnight Shift conducted four warrant sweeps, which resulted in the arrest of several fugitives, as well as assisting the DuPage County Anti-Gang Team (ATAC) with a saturation operation in known gang areas. In addition, four officers were selected to join the ATAC team due to their dedication to combating street gangs. This goal was accomplished.*
3. **Schedule five in-house training sessions for officers (K9 Searches, Debriefing Informants, Children's Center Cases, Gang Trends, Hospital DUI Arrests).**  
*Three formal in-house training sessions were conducted in 2017, which included presentations from the DuPage County Children's Center, YWCA (domestic violence resources and services) and the FBI (lone -wolf terrorist threats). In addition, several informal training sessions were conducted regarding juvenile procedures and legal updates, the proper handling of narcotics due to Fentanyl exposure, and Department programs for special needs citizens. This goal was accomplished.*
4. **Increase parking tickets issued by 5%.**  
*The goal was 5,389 issued parking tickets. Officers issued 3,236 parking citations in 2017. This goal was not accomplished.*
5. **Initiate six pro-active investigations.**  
*Midnight Shift officers initiated nine pro-active investigations in 2017. As a result of these investigations, several arrests were made for prostitution, delivery of controlled substances and possession of controlled substances. In addition to these charge, large amounts of narcotics and United States currency were seized as a result of these investigations. This goal was accomplished.*
